



Enquiries About Results (EAR) – Summer 2019

If you are disappointed in your results you **must talk to your teacher or head of department** in the first instance. They will help you review the grade boundaries. This tells you how far away you are from the next grade. If you are more than 4 or 5 points away from the next grade, a review is unlikely to have an impact for you. Last year, most changes were no more than 1-3 marks. Approximately 40% of the reviews requested resulted in a grade change.

The grade boundaries are published by each exam board on results day. The following are page links to where they should be located.

Once you have established that you are close to the next higher grade boundary, you can consider requesting a remark. You should then consider which unit(s) to get remarked. A conversation with your teacher or head of department is strongly advised prior to making a decision. If you chose to request an EAR there are three possible outcomes, your grade can remain the same, be lowered or increased.

The table attached details what type of enquiries are available from the exam boards and the relevant deadlines and costs;

If you decide to request an EAR, you must complete the 'EAR Student Request' form. Payment for these services are payable immediately on ParentPay.

| Service 2P Priority Review of Marking (AS/A Level) Available up to Thursday 22nd August 2019⁽²⁾ | £58 | A quicker service only available to students who have a university place or other higher education institution offer pending ⁽²⁾ |
| Access to Scripts (Copy) by Thursday 19th September 2019 | £13 | This is a photocopy of the marked exam paper that you can use to review work for future information. |
